Describe your personal history with, and passion for Newport County AFC.

What skills and experience would you bring to the Trust if elected?

As a professional accountant and auditor, I am able to bring my knowledge of good governance and sound management to the Board of the Trust. I can reflect on my experience of the corporate world to help identify new opportunities for the Trust to grow and enhance its operating model.

My knowledge of data analysis and reporting, coupled with social media platform experience, will allow me to support the Trust's presence and influence on platforms such as Facebook and Instagram which in turn could help generate engagement with the wider football community.

How would you stay in touch with Trust members to be able to represent their views and voice their issues?

I believe that working in partnership with others, we can make a significant difference to the way the Trust is presented to the fans and the wider footballing community.

In addition, my understanding of the financial landscape would enable me to support the financial reporting and governance requirements bestowed upon us by our regulators.
